Welcome New Parks and Recreation Board Member:

Heather welcomed Anne Lipp to the Parks and Recreation Board as the new Alternate Board Member. Anne shared with the Parks and Recreation Board that she grew up in Birmingham, was a competitive figure skater, performed in thirteen ice shows and was involved with Parks and Recreation programs.

Anne stated she has two young children who love to ice skate and are involved with the City of Birmingham ice skating program and looks forward on being involved with the Parks and Recreation Board.

AGENDA ITEM #1: Parks and Recreation Rules-Final Revision

Carrie stated that the city attorney has reviewed the Parks and Recreation Board changes made to the Parks and Recreation Rules from the November 10, 2020 meeting and have approved two out of the three recommendations the Parks and Recreation Board recommended.

The city attorney advised that the Smoking Rule remain as recommended at the November 10, 2020 Parks and Recreation Board meeting.

The Smoking Rule will read: The use of marijuana products on public property is illegal even in locations where recreational marijuana is legal. In addition to state and federal regulations, Birmingham ordnance does not allow for the use of marijuana on public property. CBD oil and products do not fall in the category of "marijuana products".

Dominick stated on the tennis court rules signage that the following corrections be made:

- The first and second bullet the phone numbers listed should both read 248.530.1642
- Third bullet from the bottom the P in Private is struck through.

Dominick stated that on the Dog Park Rules the following correction be made:

- The sixth bullet point should read, "Users may only bring up to two dogs into the Dog Park".
- The eight bullet should read, "The following are prohibited in the Dog Park: dogs in heat, dogs under the age of four months, dogs with contagious diseases, internal or external parasites, aggressive dogs and unfixed male dogs over the age of six months."

Carrie stated that the corrections will be made to the tennis court rules and also the dog park rules.

Dominick asked is there was a rule that requires the dog to have their vaccines? Carrie stated that on the dog park application the dog license and rabies vaccines information is required prior to purchasing a dog fob.

AGENDA ITEM #2a: Request for Art Donations Installations for City Parks-"Call For Entry"

Brooks Cowan, City of Birmingham Planner presented to the Parks and Recreation Board a recommendation from the City of Birmingham Public Arts Board a Call for Entry to recruit new sculptures and artwork for the City of Birmingham. The board has prioritized five locations, three of which are located in park green space.

Brooks stated one being a vacant concrete pad at Poppleton Park at the intersection of Woodward and Madison Street.

A second being the triangular green space at the intersection of Woodward and Old Woodward at the former site of Mark Di Suvero's red metallic sculpture titled "Choopy".

A third being Linden Park which the Public Arts Board has recently recommended a sculpture "Pyramid Earth" be located.

Brooks stated the Parks and Recreation Board is required to review to recommendation before it goes to City Commission. However, the Parks and Recreation is not required to comment on the Public Arts Board recommendation of budget expenditure.

Brooks presented to the Parks and Recreation Board that a local artist Kegham Tazian has applied to donate his sculpture "Pyramid Earth" to the City of Birmingham. Pyramid Earth is three feet wide and five feet in height. The art sculpture will be installed on a granite pedestal.

Ross asked if the sculpture will be secure to the pedestal. Brooks stated that the sculpture would be bolted down if granite is used for the pedestal.

Brooks stated upon discussion with between the Public Arts Board, staff and the artist's representatives, the applicant has indicated a preference for the location at Linden Park, between Maple Road and the Rouge River.

The sculpture is also required to be reviewed by the Parks and Recreation Board before going to City Commission. The Parks and Recreation Board is not required to comment on the Public Arts Board recommendation to spend money from their budget.

SUBJECT: Birmingham Ice Sports Arena A/E Services Award

INTRODUCTION:

The Birmingham Ice Arena (BIA) is slated for necessary Ice Plant equipment replacement including a new in-floor piping system and sub-floor heating for this fiscal year in the Approved 2020-2021 Budget. In addition, with the approval of the Parks and Recreation Bond in November, building facility improvements may also be accomplished at this time.

BACKGROUND:

The Birmingham Ice Arena is a 47-year-old facility enjoyed and beloved by the community over the years. Regionally, it serves Michigan Amateur Hockey Association (MAHA) District 4. It is home to Birmingham High School Hockey (Birmingham Unified), the Birmingham Hockey Association (BHA) and the Figure Skating Club of Birmingham (FSCB). Residents and non-residents alike share in the costs to utilize this facility. It is a "pay to play" model in which clubs and organizations pay an hourly rate to "rent" the ice. The BIA also offers skating lessons, and public open skate sessions contributing to the revenue. The majority of all revenue received at the ice arena is from ice-rental contracts with organizations such as BHA, BU, FSCB and other leagues. Second to Ice Rental revenue, is Learn to Skate revenue.

For the fiscal year 2019-2020, the resident/non-resident ratio is as follows: Learn to Skate Lessons: 52% Residents, 48% Non-Residents; Public Open Skate Lessons: 44% Residents, 56% Non-Residents; BHA: 44% Residents, 56% Non-Residents; FSCB: 78% Residents, 22% Non-Residents.

This well maintained facility is aging, having experienced an in-ground pipe leak in 2017 and other significant mechanical repairs needed in recent years as well. Thankfully, the 2017 leak was located in an accessible area, and repaired, however a new ice plant and piping system is necessary in order to keep the rink operational.

During the 2018 five (5) year Parks and Recreation Master Plan process, public input was gathered. As part of this process, a survey about the Ice Arena was put together and received great response. We heard from rink users that the locker rooms are excessively

small, as is the corridor leading to them. There is a need for larger locker rooms for players and hockey gear, including dedicated space for women. In addition to the survey, public meetings held conveyed the need for building improvements at the BIA.

In 2018, the City engaged Plante Moran Cresa (PMC) to perform a Facility and Operational Assessment of the Birmingham Ice Arena (BIA) with the intent to serve as a road map for future capital projects at the BIA. Recommendations for facility improvements by PMC over and above the critical need of a new Ice Plant system include: Shifting the main ice arena to the east to accommodate ADA requirements, a new Women's Locker Room, a new High School Team Locker Room, enlarging the existing locker rooms (4), and a new Studio Rink observation area/meeting room.

The City has further recently engaged the services of PMC to serve as the City's Owner Representative, to oversee all aspects of this project from design to construction.

The first step in making improvements to the Ice Arena is to secure Architect/Engineering Services to put together plans and specifications for these improvements in order to be bid out for construction. On December 2, 2020, the City issued a Request for Proposals for these services for qualified firms.

Bids were received and publicly (virtually) opened on December 17, 2020. The results of the bid opening are as follows:

City staff and PMC performed interviews and reference checks for all three (3) bidders. To be considered for this project, the Architectural/Engineering Firms had to meet the following minimum qualifications:

- The A/E team members have successfully completed a minimum of three (3) ice arena or ice arena renovation projects within ten (10) years.
- Firm has been in business for at least the last ten (10) consecutive years in the field for which the bid was solicited.
- Firm is licensed to perform the required design work in the State of Michigan.
- Be familiar with and have experience in the Municipal sector including having at least five (5) municipal clients in the last ten (10) years.

Andrus Architecture's submittal had the most impressive resume with regard to the sheer number of ice rink projects performed in MI and nationally, 26 rinks in 8 states, highlighting the following:

- Compuware Sports Arena, Plymouth, MI
- USA Hockey Ice Arena, Plymouth, MI
- NHL Skate, Birch Run, MI
- Eddie Edgar Ice Center, Livonia, MI

- Georgetown Twp. Ice Center, Hudsonville, MI
- New York Islanders at Eisenhower Park, Long Island, NY
- Dix Hills Recreation Complex, Huntington, NY
- Amesbury Sports Center, Amesbury Massachusetts (2021).

Andrus Architecture, for Ice Rink Design, won the 2005 Associated Builders & Contractors, Inc. Award for Georgetown Ice Center, and the 2010 Long Island Municipal Project of the Year for Dix Hills Recreation Center.

City Administration and PMC recommend that the Birmingham Ice Arena A/E Services project be awarded to Andrus Architecture. Our Criteria Based Selection consisted of the following factors: Similar Project Experience, Team-Member Resumes and Qualifications, Plan & Approach, Fee, Team-Member Experience together, References, and the Interview. Further, the Interview was scored on Overall Presentation, Staff and Management Approach, Team Dynamic and Interaction, Clarity of Responses and Cost Saving Opportunities.

FISCAL IMPACT:

Funds in the amount of \$2 million have been budgeted in the Approved 2020-2021 Budget in order to accomplish the critical need of new Ice Plant equipment. The projected amount for all improvements at the Ice Arena is \$ 5.1 million. This total includes design services and consultant fees. Parks and Recreation Bond Approval for the \$3.1 million allows for the design and development of this project in its entirety.

PUBLIC COMMUNICATIONS:

Public Input will be gathered as part of the design process, at the January Parks and Recreation Board meeting, and future City Commission meetings and Parks and Recreation Board meetings as well, in addition to the previous surveys, feedback and input from facility users.

SUMMARY:

The Department of Public Services and PMC recommend awarding the Architecture Engineering Services project to Andrus Architecture for a total not to exceed \$286,900.00 with a not to exceed reimbursable expense of \$2,000. Please find letter of recommendation and PowerPoint Presentation from PMC following this report. Andrus is enthusiastic and able to hit the ground running for this project. Andrus Architecture's team is comprised of staff with explicit ice arena experience and B32° Engineering with countless ice arenas on their resume as well. PMC and DPS are confident in Andrus Architecture's ability to perform the services as requested. The designs will be reviewed publicly for input, presented to the Parks and Recreation Board, Planning Board, and City Commission for approval, with a hard deadline to be bid out for construction in April 2021. Andrus Architecture is aware of this intense schedule, and is energetic to get started.

SUGGESTED RESOLUTION:

To recommend the Birmingham Ice Arena Architectural and Engineering Services project award be to Andrus Architecture and forward to the City Commission for approval.

Dear Ms. Wood:

This letter is to update you on Plante Moran Cresa's (PMC) progress in our assignment to assist and advise the City of Birmingham (CB) in the selection of a Design Consultant firm for the CB Sports Ice Arena Renovation/Additions Capital Improvement Project (Project). The CB's Parks & Recreation Department and Plante Moran Cresa (Project Team) solicited and received proposals from three (3) qualified Architecture/Engineering (A/E) consultant firms.

SELECTION PROCESS

This letter communicates the results of the independent Criteria Based Selection (CBS) process the Project Team were directed to conduct in accordance with our engagement, as well as the resulting recommendation for selecting a A/E consultant firm for the Project.

PMC formulated a Criteria Based Selection (CBS) process to evaluate the submissions of each of the A/E consultant firms. A CBS process uses pre-established and weighted criteria to objectively evaluate and score the proposals and provide recommendations for awarding contracts. PMC conducted an initial CBS process with the information obtained from the RFP responses received on December 17, 2020. Each of the three A/E firms were interviewed on December 22, 2020 and scored based on the CBS criteria.

RECOMMENDATION

The Project Team believes that each of the three A/E firms that responded to the RFP are qualified and capable of meeting the Project's requirements, however, the CBS process presents **Andrus Architecture** as the top firm based on their scoring of each of the RFP and interview CBS criteria . This recommendation is in large part due to Andrus's resume of experience of similar projects, team member resumes, knowledge of ice plant equipment, energy saving opportunities and lowest overall cost. Based on the results of the CBS process, the Project Team recommends awarding the Consultant contract for the CB Ice Sports Arena Renovation/Additions Capital Improvement Project to **Andrus Architecture** in the amount of **\$286,900.00** with the a not to exceed reimbursable expense of **\$2,000.00**. The cost of this work will be detailed in a contract pending final review and approval of terms by the CB legal counsel.




Birmingham Ice Sports Arena - Facility Needs







This letter is to update you on Plante Moran Cresa's (PMC) progress in our assignment to assist and advise the City of Birmingham (CB) in the selection of a Design Consultant firm for the CB Sports Ice Arena Renovation/Additions Capital Improvement Project (Project). The CD's Parks & Recreation Department and Plante Moran Cresa (Project Team) solicited and received proposals from three (3) qualified Architecture/Engineering (A/E) consultant firms.

SELECTION PROCESS

This letter communicates the results of the independent Criteria Based Selection (CBS) process the Project Team were directed to conduct in accordance with our engagement, as well as the resulting recommendation for selecting a A/E consultant firm for the Project.

PMC formulated a Criteria Based Selection (CBS) process to evaluate the submissions of each of the A/E consultant firms. A CBS process uses pre-established and weighted criteria to objectively evaluate and score the proposals and provide recommendations for awarding contracts. PMC conducted an initial CBS process with the information obtained from the RFP responses received on December 17, 2020. Each of the three A/E firms were interviewed on December 22, 2020 and scored based on the CBS criteria.

RECOMMENDATION

The Project Team believes that each of the three A/E firms that responded to the RFP are qualified and capable of meeting the Project's requirements, however, the CBS process presents Andrus Architecture as the top firm based on their scoring of each of the RFP and interview CBS criteria. This recommendation is in large part due to Andrus's resume of experience of similar projects, team member resumes, knowledge of ice plant equipment, energy saving opportunities and lowest overall cost. Based on the results of the CBS process, the Project Team recommends awarding the Consultant contract for the CB Ice Sports Arena Renovation/Additions Capital Improvement Project to Andrus Architecture in the amount of \$286,900.00 with the a not to exceed reimbursable expense of \$2,000.00. The cost of this work will be detailed in a contract pending final review and approval of terms by the CB legal counsel.

Capital Projects Sub-Committee Progress Report

December 15, 2020

From: City of Birmingham Parks & Recreation Board Capital Projects Sub-Committee (Heather Carmona, Susan Collins, John Rusche Lauren Wood, Carrie Laird)

The second meeting of the sub-committee was on December 15.

We recognize that citizen engagement is particularly important as we move forward. We are looking for opportunities to place key decisions on the City Commission agenda, with time for the public to be made aware and participate.

Ice Arena

- 1. Lauren, Carrie and Connie have been working very hard to move things along as quickly as possible.
- 2. Staff presented a preliminary schedule noting several near-term dates detailed below.
- Working with Plante Moran Cresa (PMC), on December 2 an RFP was issued for architectural/engineering (A/E) design services. About 50 firms received the RFP through the Michigan Inter-Governmental Trade Network (MITN) and through PMC. Proposals are due December 17.
- 4. The bids will be reviewed and negotiated as required and the preferred A/E firm will be presented to the P&R Board on January 5 by Robert Stempien from PMC. With public notice in advance.
- 5. January 11, the recommended A/E firm will be presented to the City Commission. Again, with public notice in advance. Most of the renovations will be on the interior of the building with some expansion for locker rooms. Members of the Capital Projects Subcommittee are planning to attend to answer any questions the City Commission or public may have.
- 6. January 23 Lauren and Robert will participate in the City Commission long range planning meeting to provide status and some projected financials. This could form the basis for an ongoing revenue and expense report.
- 7. March 10 an RFP for a general contractor will be issued. Bids due March 24.
- 8. April 6 the preferred general contractor will be presented to the P&R Board by Robert Stempien with public notice in advance. April 12 the preferred general contractor will be presented to the City Commission, again with public notice in advance.
- 9. The Parks Bond website will be updated regularly, with focus on making it easy for the public to find the information.

Adams Park

- 10. Michael Dul and Associates created a final concept plan dated October 27, 2016, found on page 156 of the 2018 Parks and Recreation Master Plan. It was the result of many meetings with the neighborhood and Roeper School.
- 11. City staff conducted a site review with Michael. Next step is to receive his written proposal to reengage his services.
- 12. February 8 is the likely City Commission meeting at which they discuss the approval of working with Michael Dull.
- 13. Staff will revisit the concept plan with City administration, the two neighborhood groups most affected and involved, and with Roeper. Roeper's input will be important regarding the shot put and long jump runway. Are they still important? These meetings could be in February.
- 14. Construction would be planned for summer 2022.

P&R Bond Timeline

- 15. Below is a priority list. Pieces of many projects will be running simultaneously.
- 16. Schedule I -- \$4,750,000 bond sale probably in May. If so, a resolution needs to go to the Commission in March or April. These projects will be undertaken in 2021-2024.
 - a) Ice Arena
 - b) Adams Park
 - c) Booth Park Corner Feature. Also, a Michael Dul project seating, trees landscaping.
 - d) Pickleball (data and location)
 - e) Rouge River Trail Corridor
- 17. Schedule II -- \$6,500,000
 - f) Springdale Golf Course irrigation improvements (\$525,000) need to be accelerated. Would like to do in October 2021. May not be bond funds. We need to stay with the \$4,750,000.
 - g) Playgrounds need some planning, but we should not engage with the neighborhoods too early because the bond series would not be sold until 2024. A schedule will be discussed at our January meeting.

We should be open minded and flexible. Some projects may move depending upon cost.
